PROCESS

- Ask your local physician to request a Johns Hopkins Gastroenterology and Hepatology Remote Second Opinion.*
- Complete all forms and mail us copies of your pertinent medical records and diagnostic tests.
- Within approximately 10 business days from the time we receive your records and payment, we will mail or fax to you and your local physician a letter containing our assessment and recommendations.

COST

Our Remote Second Opinion Program is a self-pay service that is not covered by health insurance. The basic cost for this service is \$550 plus an additional fee if a pathology or radiology review is needed. Payment by major credit card (MasterCard, Visa, American Express and Discover) is due at the time of the request.
